



DRIVING DIRECTIONS

Thank you for choosing Eden Prairie Center, a favorite shopping, family entertainment and dining destination. We are located in Eden Prairie at **8251 Flying Cloud Drive (zip code 55344)**, which is just south of the intersection of I-494 and Flying Cloud Drive.

Once in this business district of the city of Eden Prairie, motorists may find it helpful to follow the 2-way city streets of Prairie Center Drive and Valley View Road which form a 4.0 mile “loop” and encircle several businesses in this shopping area, including Eden Prairie Center.

Prairie Center Drive forms a two-way “horseshoe loop” around the east, south and west perimeter of the “loop”, while Valley View Road connects the “loop” on the northern perimeter stretch of this road system.

For reference, Cub Foods is inside the eastern side of this “loop”. Eden Prairie Center is inside the southern circle of this “loop”. Bachman’s Floral and Garden Center is inside the western side of this “loop”. Home Depot is located at the northwest corner of this “loop” at Prairie Center Drive and Valley View Road. First Western Bank & Trust is inside the northeast corner of this “loop” at Prairie Center Drive and Valley View Road.

Flying Cloud Drive runs north and south as a spine through the middle of this business district.

DRIVING DIRECTIONS

ROUTES FROM THE EAST

Heading west on I-494:

Continue through the city of Bloomington past the Hwy. 169 exits into the city of Eden Prairie. Take the next exit from I-494 which is the Prairie Center Drive exit (Exit 11A). After initially exiting, veer right and continue to follow Prairie Center Drive directional. At the stoplight at the bottom of this exit ramp, turn left onto Prairie Center Drive under the I-494 overpass bridge. Follow Prairie Center Drive through the first traffic signal located at the West 78th Street intersection. Turn right at the first driveway into Eden Prairie Center near U.S. Bank.

Heading west on Hwy. 62 (Crosstown):

Merge left (southwest) onto US-212 West and past the CR-61 North/Shady Oak Road exit. Take the next exit which is marked CR-39/Valley View Road and CR-61 South (no Exit number) and stay in the left lane. (Eden Prairie Center is 0.8 miles from this exit.) At the top of this exit ramp (stoplight), turn left onto Valley View Road which will turn into Prairie Center Drive. Continue to follow Prairie Center Drive through the West 78th Street intersection (stoplight). Turn right at the first driveway into Eden Prairie Center near U.S. Bank.

ROUTES FROM THE WEST

Heading east on Hwy. 5:

Merge onto US-212 east (*old Hwy. 312 east*). Take the Prairie Center Drive exit. At the end of the exit ramp (stoplight), turn right and follow Prairie Center Drive 0.8 miles. Cross the Flying Cloud Drive/CR-61 intersection (stoplight). Turn left at the first driveway into Eden Prairie Center near Arby's.

Heading east on US-212 (*old Hwy. 312 east*):

Take the Prairie Center Drive exit. At the end of the exit ramp (stoplight), turn right and follow Prairie Center Drive 0.8 miles. Cross the Flying Cloud Drive/CR-61 intersection (stoplight). Turn left at the first driveway into Eden Prairie Center near Arby's.

Heading east (north) on Flying Cloud Drive/CR-61 (*old US-212*):

Continue to follow Flying Cloud Drive/CR-61 east past Flying Cloud Airport and north toward Eden Prairie Center. Cross the Prairie Center Drive intersection (stoplight). Turn right at the first driveway into Eden Prairie Center near McDonald's and TCF Bank.

ROUTES FROM THE NORTH

Heading south on I-494:

Take the Valley View Road exit (Exit 12). At the top of the exit ramp (stoplight), turn left onto Valley View Road and travel approximately 0.8 miles where Valley View Road will turn into Prairie Center Drive. Continue on the same road by following Prairie Center Drive for approximately 0.8 more miles. Drive through the West 78th Street intersection (stoplight). Turn right at the first driveway into Eden Prairie Center near U.S. Bank.

Heading south on US-212 West:

Pass the CR-61 North/Shady Oak Road exit. Take the next exit which is marked CR-39/Valley View Road and CR-61 South (no Exit number) and stay in the left lane. (Eden Prairie Center is 0.8 miles from this exit.) At the top of this exit ramp (stoplight), turn left onto Valley View Road which will turn into Prairie Center Drive. Continue to follow Prairie Center Drive through the West 78th Street intersection (stoplight). Turn right at the first driveway into Eden Prairie Center near U.S. Bank.

Heading south on Hwy. 169:

Take the W 78th St exit. Follow the frontage road to a round-about and exit to I-494 West. Follow I-494 West 1.0 mile and take the Prairie Center Drive exit (Exit 11A). After initially exiting, veer right and continue to follow the Prairie Center Drive directional. At the stoplight at the bottom of this exit ramp, turn left onto Prairie Center Drive under the I-494 overpass bridge. Follow Prairie Center Drive through the first traffic signal located at the West 78th Street intersection. Turn right at the first driveway into Eden Prairie Center near U.S. Bank.

Heading south on Hwy. 100:

Take the I-494 West exit. Follow I-494 West 3.1 miles and take the Prairie Center Drive exit (Exit 11A). After initially exiting, veer right and continue to follow Prairie Center Drive directional. At the stoplight at the bottom of this exit ramp, turn left onto Prairie Center Drive under the I-494 overpass bridge. Follow Prairie Center Drive through the first traffic signal located at the West 78th Street intersection. Turn right at the first driveway into Eden Prairie Center near U.S. Bank.

Heading south on CR-61/ Shady Oak Road:

Take a right on Bryant Lake Drive and follow for approximately 0.9 miles. Turn right to stay on Bryant Lake Drive for another 0.2 miles - Follow the left lane until you reach an intersection (stoplight). (Eden Prairie Center is 0.8 miles from this intersection.) Turn left at this intersection onto Valley View Road which will turn into Prairie Center Drive. Continue to follow Prairie Center Drive through the West 78th Street intersection (stoplight). Turn right at the first driveway into Eden Prairie Center near U.S. Bank.

Heading south on I-35W:

Take the I-494 West exit. Follow I-494 5.7 miles and take the Prairie Center Drive exit (Exit 11A). After initially exiting, veer right and continue to follow Prairie Center Drive directional. At the stoplight at the bottom of this exit ramp, turn left onto Prairie Center Drive under the I-494 overpass bridge. Follow Prairie Center Drive through the first traffic signal located at the West 78th Street intersection. Turn right at the first driveway into Eden Prairie Center near U.S. Bank.

ROUTES FROM THE SOUTH

Heading north (east) on Flying Cloud Drive/CR-61 (*old US-212*):

Continue to follow Flying Cloud Drive/CR-61 (*old US-212*) east past Flying Cloud Airport and north toward Eden Prairie Center. Cross the Prairie Center Drive intersection (stoplight). Turn right at the first driveway into Eden Prairie Center near McDonald's and TCF Bank.

Heading north on Hwy. 169:

Take the I-494 West exit. Follow I-494 West 1.0 mile and take the Prairie Center Drive exit (Exit 11A). After initially exiting, veer right and continue to follow Prairie Center Drive directional. At the stoplight at the bottom of this exit ramp, turn left onto Prairie Center Drive under the I-494 overpass bridge. Follow Prairie Center Drive through the first traffic signal located at the West 78th Street intersection. Turn right at the first driveway into Eden Prairie Center near U.S. Bank.

Heading north on Normandale Boulevard:

Take the I-494 West exit. Follow I-494 West 3.1 miles and take the Prairie Center Drive exit (Exit 11A). After initially exiting, veer right and continue to follow the Prairie Center Drive directional. At the stoplight at the bottom of this exit ramp, turn left onto Prairie Center Drive under the I-494 overpass bridge. Follow Prairie Center Drive through the first traffic signal located at the West 78th Street intersection. Turn right at the first driveway into Eden Prairie Center near U.S. Bank.

Heading north on I-35W:

Take the I-494 West exit. Follow I-494 5.7 miles and take the Prairie Center Drive exit (Exit 11A). After initially exiting, veer right and continue to follow Prairie Center Drive directional. At the stoplight at the bottom of this exit ramp, turn left onto Prairie Center Drive under the I-494 overpass bridge. Follow Prairie Center Drive through the first traffic signal located at the West 78th Street intersection. Turn right at the first driveway into Eden Prairie Center near U.S. Bank.
